161. Declarations of interest

162. Minutes of the meeting of 4th January 2017

The Council agreed that the minutes of the meeting of the 7th January 2017 were an accurate record of the proceedings.

163. Progress on Parish matters

(a) Road/path repairs.

Road repairs are still delayed due to broken machinery. The Clerk will continue to chase.

(b) Quarry Entrance

The Clerk will investigate the purchase of a chain and two concrete blocks to block the entrance.

c) No 18 Bus

The bus service is operating satisfactorily and blockages in Church Street, due to parked cars, has improved now that traffic cones have been put out at critical locations.

d) Telephone box. BT have now advised us that the box cannot be sold to the community for £1 as the land is owned by a third party. The box will therefore be removed in due course.

165. Community Transport

There has been no further news from Fringford.

166. Emergency Plan/Resilience Grant

Cllr Hopkins reported that the generator arrived on 16th January 2017 and is now stored in the Church. Work to the electricity supplies for the generator and defibrillator should start on 11th February.

The Parish Council has now received a small number of leaflets from SSE to explain a registration service for residents with priority needs in the case of a power outage. The Parish Council agreed that these should be distributed and, if residents were minded to complete them Councillors would offer assistance.

167. Un-metalled footpaths and bridleways

Cllr Hopkins has obtained a plan showing the footpaths in the village. He has also recruited a number of volunteers to walk to footpaths and report any problems to him. It was agreed that Councillors would arrange to walk the footpath leading through to the hunt premises (between the Rectory and the Hall), as there had been a number of complaints that horses were churning up the wet surface.

168. Vehicle Activated Sign

Ongoing. The intention to acquire one of these remains an objective once funds have been created.

169. Cars and bins

It was reported that the car parked on the Bicester Road with a damaged wheel had now been removed and bins have been taken more quickly back into the curtilage of properties. It was noted, however, that cars were still occasionally parked on the grass verge.

170. Hospital trust consultation

The Council noted the current consultation into the future plans of the Hospital Trust and agreed that the Clerk should respond by asking the Trust to ensure that there was adequate provision for the residents of Bicester and Banbury in the light of current plans for residential development in those towns.

171. Spring Clean

The Parish Council agreed to arrange a Spring Clean session in the village for Wednesday 22nd March. The Clerk was asked to request more hoops to hold litter bags open.

172. One Oxfordshire Unitary Authority consultation

The Parish Council noted the consultation from Oxfordshire County Council regarding the creation of a single Unitary Authority for Oxfordshire. After discussion the Clerk was asked to respond to the County Council indicating that the Parish Council could not support the proposals, as they felt that a single authority would be remote from its parishes, there would be a democratic deficit in terms of local representation and that while the proposals would probably achieve savings of £20 Million per year, these were a very small proportion of the Oxfordshire Council's annual turnover of approximately £1 Billion.

The parish Council resolved to object to this application on the basis that the proposed development will break up the continuity of the wall fronting Bicester Road, which is a major gateway into the village. Furthermore the Council believes that the existing property has been used as a garage for decades rather than a dwelling house.

The Council believes that the proposal will have considerable visual impact on the village conservation area and will affect the setting of the Red Lion Public house. Furthermore the Council believes that the existing property was formerly a garage rather than a dwelling house.
