The Chairman and another councillor recently met with the Management, for a presentation on their future plans for Bicester Heritage including the Quarry and unveiled their new group name 'Bicester Motion'. When preparing their plans the management of the site's ecology and the need to ensure that public access is permitted, is understood and will form part of their plans. The Parish Council extended an invitation for them to attend the Parish Open Meeting on 9th April and this was accepted.

174. Unmetalled roads and footpaths report

175. VAS

The Council agreed to consider the purchase of another VAS. They will look at other manufacturers including Elan City, and will make an application to Cllr Corkin's Community Fund for support.

176. SA Community Emergency Plan

A final draft with slighted amended wording was approved and a hard copy of the revised plan would be displayed on the notice board in the church.

177. Oxford Wild Life Trust initiative

The landowner of the pond has agreed to meet a representative of the Berks Bucks and Oxon Wildlife Trust, to discuss what they do as an organisation and how they might be able to offer advice for maintaining the good health of fresh water areas such as the Pond. Cllr Edwards agreed to facilitate contact between the parties.

178. Pound area Pocket Park

The Parish Council has received an offer of a grant for the amount requested from the Ministry of Housing Communities and Local Government . The Council offered its congratulations to the Chairman – who had put in a considerable amount of work on the application. There will be an information event for residents in the Church on Tuesday 12th March and a publicity sheet circulated to all households with wider publicity via the website. The grant requires some match funding form Cherwell District Council and a contribution for the Parish which will be taken out of the Village Improvement Fund. The works will proceed fairly quickly.

179. Pond Path

This will be considered at the next Parish Council meeting.

180. Defibrillator

The Parish Council agreed to consider the purchase of another defibrillator.

There has been a proposal that the defibrillator is kept unlocked for easy access. After investigation, and as the Clerk has been advised that the council's insurers support the proposal that the box is unlocked, it was decided that the code for the box should be readily available so that there are no delays, should it require to

be used. Furthermore it was agreed that more publicity to identify the location of the defibrillator would be considered on noticeboards, the website and in the Parish news.

181. CLP update

The CLP group meets monthly and has between 8 and 12 members. There will be Ferret Racing on 5th July in the hunt paddock Last night of the Proms dinner in the Church on 14th September. A full list of events will be published.
