

Minutes of the Stratton Audley Parish Council on Wednesday 3rd July 2019

36. Minutes of the meeting of 3rd July 2019

The Council agreed that the Minutes of the meeting of the 3rd July 2019 were an accurate record of the proceedings, save that a couple of residents have not been given welcome packs yet.

Cllr Flack declared a personal interest as a member of the Stratton Audley PCC, and Cllr Edwards declared a personal interest as a neighbour of a planning applicant.

39. Progress on Parish matters

Bicester heritage/Quarry Update

It was understood that a planned meeting between CDC and the owners had been postponed however, OCC's ecologist will be meeting Bicester Heritage's ecologist to discuss the restoration of the Quarry.

Oxfordshire Wildlife Trust

A representative of the Trust has met the owner of the land by the pond, and discussed ways of improving conservation, with help from volunteers.

Traffic cones by Church

The Parish Council has asked OCC to put white lines along the road by the Church and opposite the Mallories on Church Street.

The Parish Council believes that it is now the intention to divert more construction traffic off the M40 at junction 10 and then on to Finmere. The junction off the A4421 by Stratton Park will no longer include the ghost turn (right turn) lane. This move appears to be supported by residents. Works to the Stratton Park road will however still be required.

Mallories fingerpost

The owner has agreed to replace the finger sign post that was damaged by lorries during the works.

VAS

The Clerk was asked to apply to Cllr Corkin's Priority Fund for support for a second VAS in the village.

Second Defibrillator

Plans to install a second defibrillator next to the post box are still live but the owner of the Old Post Office needs to be contacted and funding is not yet in place.

41. Pound Area Pocket Park

The front wall has now been finished apart from being topped. Work is starting on the installation of kissing gates to give access to footpaths. Groundworks to grade the site will start on weekend of 14th July. A further draft of the copy of the information to be used on the information board that will be located in the Pound area was discussed, and the Parish Council agreed by a majority of voting councillors to include an attribution to The Chairman of the Parish Council, as well as Cherwell DC . It was agreed that any further comments should be sent to the Chairman immediately and that the board should then proceed to production without delay. The Parish Council agreed to place a second noticeboard to give details of local walks.

The Parish Council agreed to make an ex gratia payment to recognise the work a resident has carried out erecting the gates on and around the Pound.

42. Roads

The Clerk was asked to request OCC refresh the paint markings on the road including the 30mph limits at the four entrances to the village. The Council agreed to ask Mike Gore to let them have an estimate of the cost of cleaning and repairing if necessary, the white gates at the village entry points, although initially the Council will approach volunteers to carry out this work. Additionally it was noted that the notice board needs renovating and a quote will be sought for this also.
