

Minutes of the Stratton Audley Parish Council on Wednesday 7th August 2019

36. Minutes of the meeting of 3rd July 2019

The Council agreed that the Minutes of the meeting of the 3rd July 2019 were an accurate record of the proceedings, save that the issue t 1 Cavendish Place was a fence not a wall.

37. Declarations of Interest

Cllr Flack declared a personal interest as a member of the Stratton Audley PCC, and Cllr Edwards declared a personal interest as a neighbour of a planning applicant.

38. Public participation

A member of the public attended to give voice to an opposing view held by many villagers to the petition regarding the attribution proposed on the Pound information panel. The Parish Council was told that many villagers said they disagreed, had refused to sign it, expressed distaste and said it was 'not in their name'.

39. Councillor's Report

Cllr Corkin complimented the parish council on the wide range of work they undertake on behalf of residents. He advised the meeting that OCC and Bicester Motion were now discussing the restoration of the quarry to find a way to comply with the restoration order served by the County. The position of the Council had not changed in its desire to see the land open to the public.

CDC and SNDC will be separate organisations from September, and the relationship with OCC is developing. OCC have increased spending on Children's services (fostering and safeguarding) and increased spending on highway maintenance.

There may be more news on the Oxford to Cambridge Expressway after the forthcoming spending review. E/W rail have abandoned proposals for a ghost lane on the A4421 with the junction by Stratton Audley Park. Cllr. Corkin urged residents to respond to OCC's cycling survey, and reminded the Council of the availability of an OCC 'Civils gang' available to take on minor highway works and repairs at a cost of some £500 per day for the gang.

The planning appeal against refusal of warehousing at Baynards Green has been rejected.

42. Pound Area Pocket Park

All the stone work is now complete and the left-over stone has been used to create a ground platform for a bench and a circular floor for a picnic table. New seating has been installed and very positive feed-back has been received from numerous residents accessing the site. The Parish Council had received an unsigned letter together with a sheet of signatures objecting to the attribution on the proposed information panel and as requested this was given due consideration. As none of the signatories attended the meeting to address this matter and nothing new was raised, the Parish Council saw no reason to change the reference made to the parish council and the artwork was signed off.

Additionally the Clerk reported that following a meeting between the Chairman, herself and a planning officer from CDC to review the works and legal status adopted by the Parish Council with regard to the site, a letter clarifying the Councils position had been sent to CDC.

The information panel together with another notice board will be installed mid-September and following this an official opening will take place at the end of the month, at which point a couple of fruit trees and other plantings will take place. The specific location and construction of the stocks is still under discussion.

43. Dog waste bags

A resident has agreed to take over the distribution of the dog waste bags which the Parish council obtains from CDC. There are three dispensers located around the village and this work has been undertaken for a number of years since the PC initiated the service by Jonathan Ormerod. We thank him for his service.

44. CLP update

The Ferret Racing on 5th July in the Hunt field was a very successful event, raising over £4000. The Last Night of the Proms event in the church on 14th September 2019 is now sold out.

Manor residents will be voting to decide whether the grounds will be available to use for the 2020 Festival.
