117. Minutes of the last meeting

The Minutes of the meeting of 8th January 2020 were agreed.

118. Declarations of Interest

Cllr Flack declared a personal interest as a member of the Stratton Audley PCC.

119. Progress on Parish matters

Launton Road Pumping Station

Thames Water, having completed an initial scoping exercise of the drains, will be carrying out a camera survey later in February.

Second VAS

The second VAS has been erected in Stoke Lyne Road. The Chairman has written to thank all residents involved and Cllr. Corkin. It is currently reported to be working well.

Bicester Heritage/The Quarry

Ongoing.

E/W Rail

The Transport and Works Act Order has now been granted, and enabling works are ongoing.

Oxford to Cambridge Express Highway

An update is awaited.

Pot Holes

The Parish Council is waiting for the roads in the village to be patched, not the potholes repaired. Launton Road will be the subject of a road closure notice to enable the works to proceed. The pothole outside Stratton house has been sprayed but additional work is required.

Footpaths

The Parish Council has now ordered the new gate to replace the stile on the footpath behind the old Green barn development and arrangements have been made for it to be installed.

OCC have carried out resurfacing to the path at the bottom of Cherry Street by the pond. Separately the Parish Council had obtained a free bag of gravel to replace the broken bag for the Cross Bucks Way path.

Additionally, restoration work to the Footpath off the Bicester Road by the Hunt Kennels is due to be carried out in the next few weeks.

Verges in Launton Road

Concern has been raised about lorries mounting and damaging the verges in Launton Road near the Old Dairy. The Parish Council has asked OCC to consider the installation of posts along the verge.
